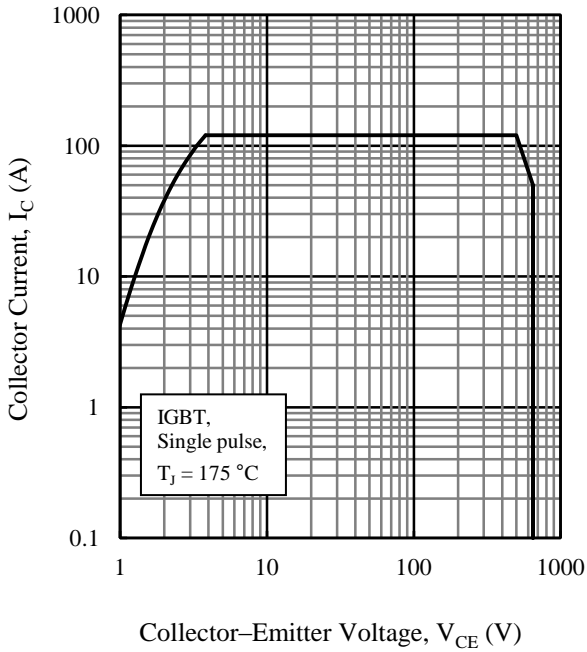


Figure 2. IGBT Reverse Bias Safe Operating Area

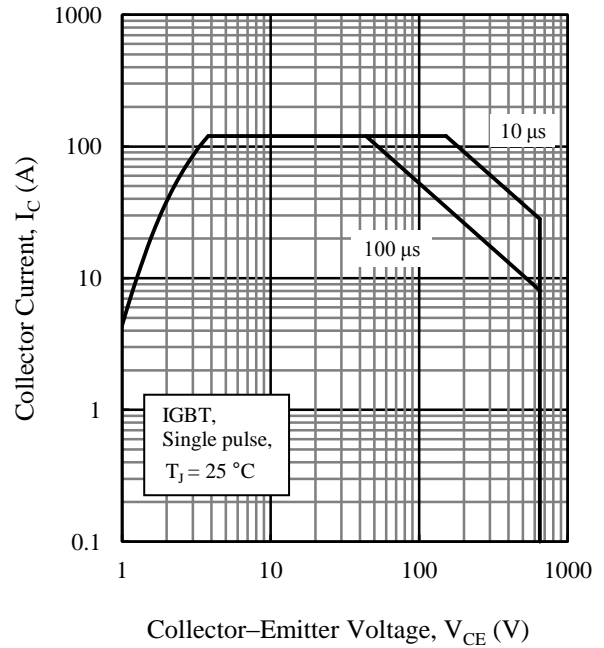


Figure 3. IGBT Safe Operating Area

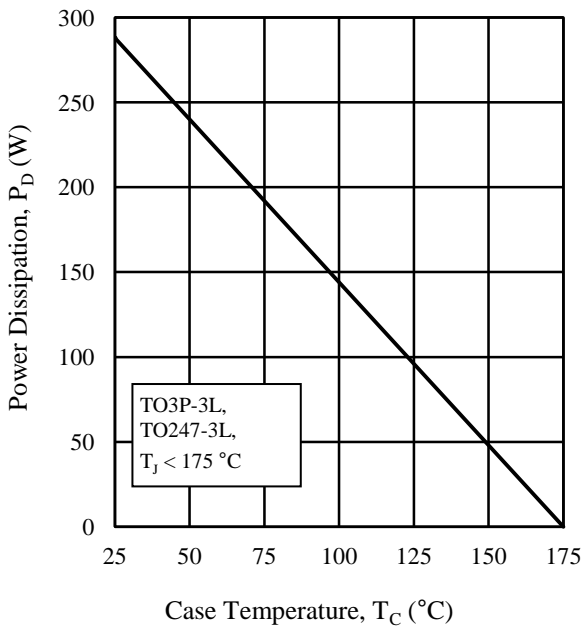


Figure 4. Power Dissipation vs. TO3P-3L and TO247-3L Case Temperature

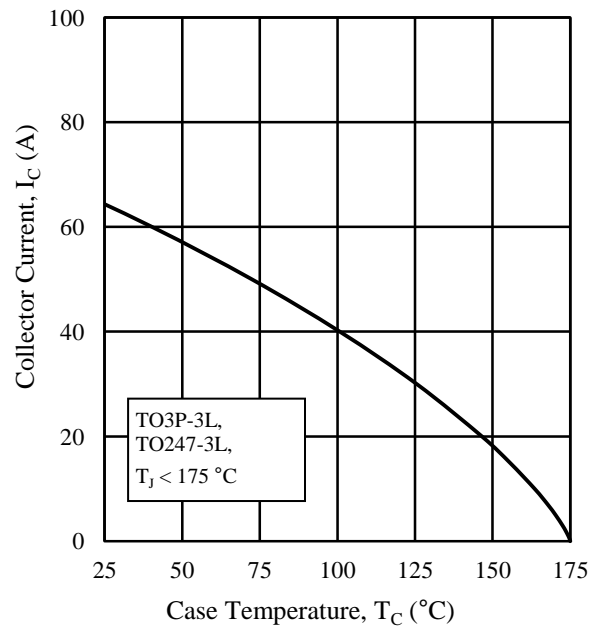


Figure 5. Collector Current vs. TO3P-3L and TO247-3L Case Temperature

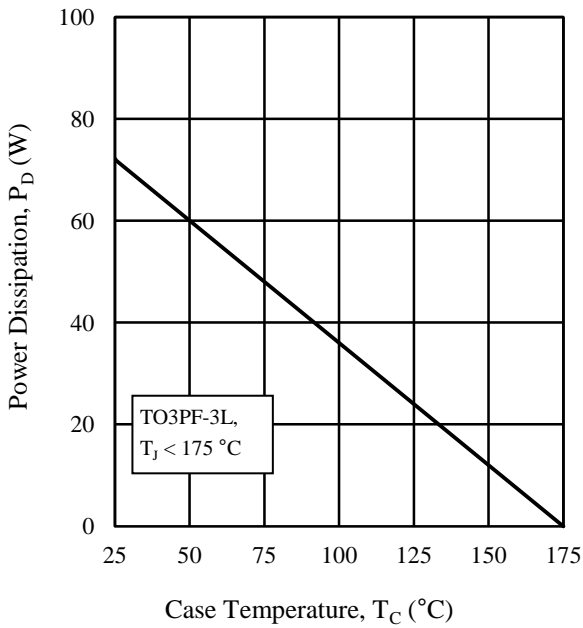


Figure 6. Power Dissipation vs. TO3PF-3L Case Temperature

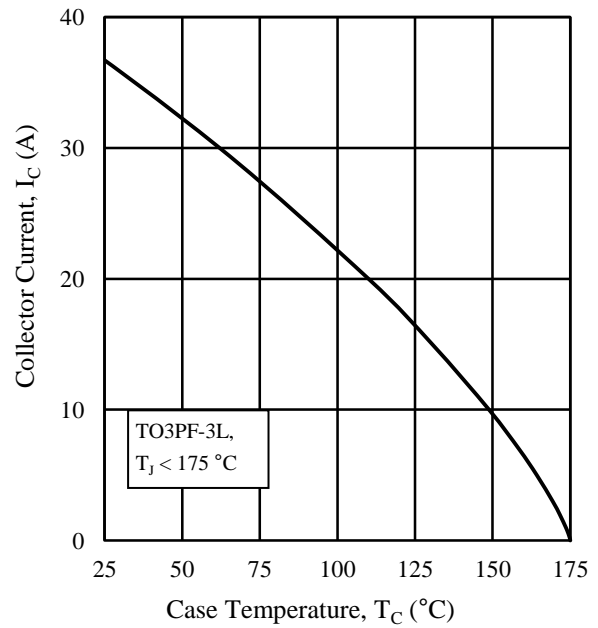


Figure 7. Collector Current vs. TO3PF-3L Case Temperature

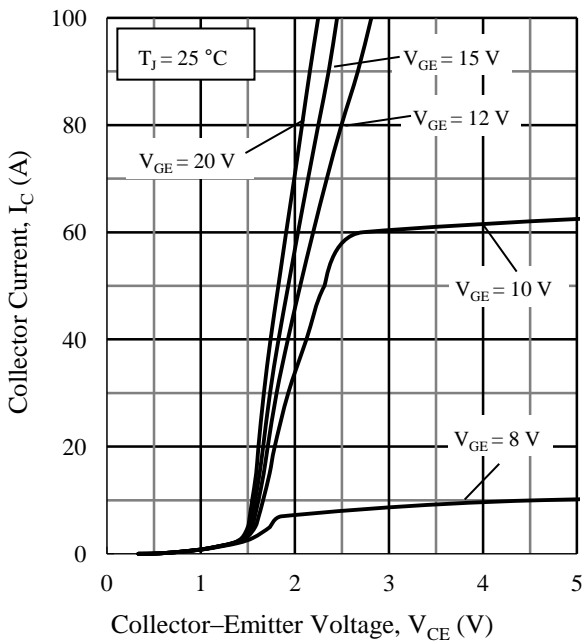


Figure 8. Output Characteristics ( $T_J = 25\text{ °C}$ )

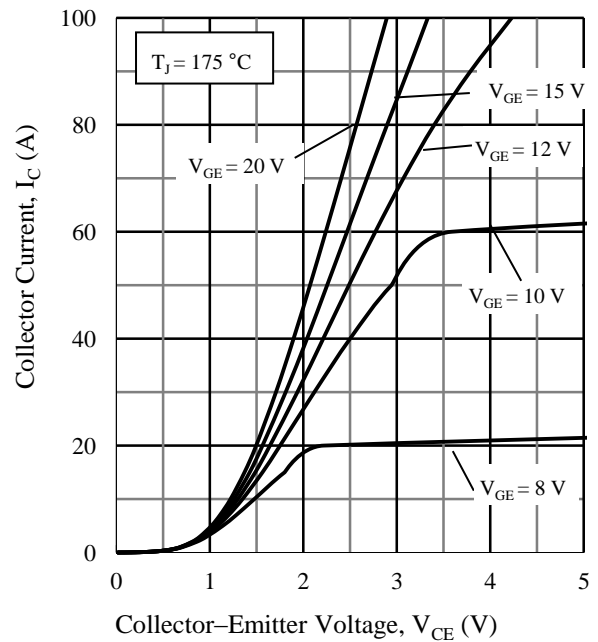


Figure 9. Output Characteristics ( $T_J = 175\text{ °C}$ )

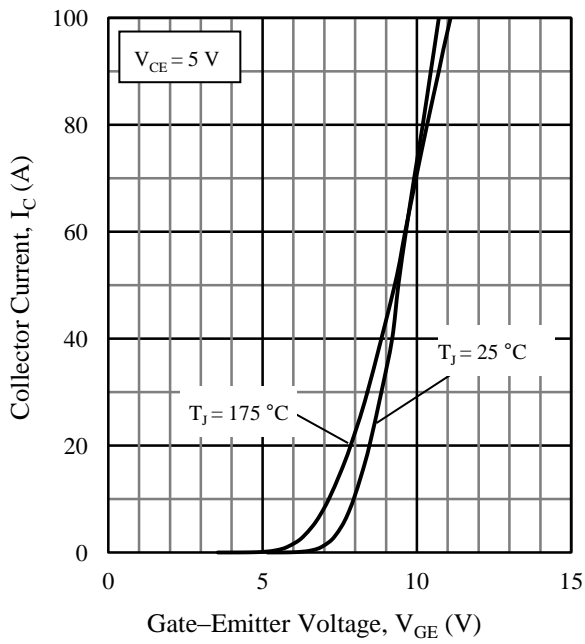


Figure 10. Transfer Characteristics

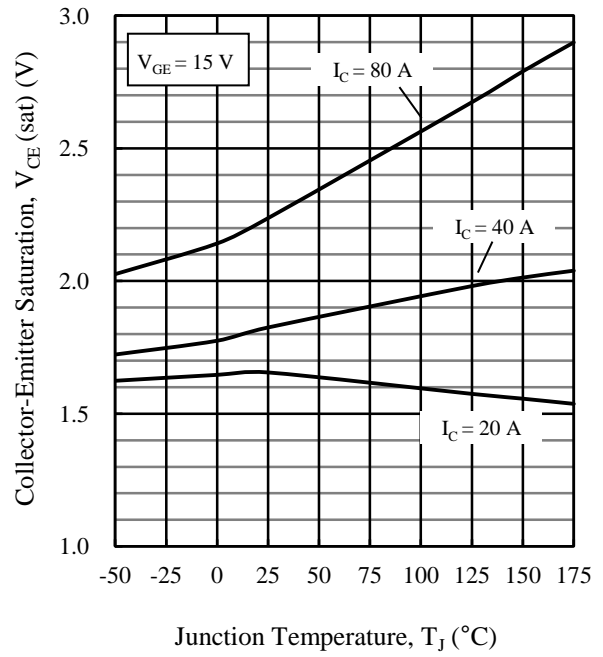


Figure 11. Saturation Voltage vs. Junction Temperature

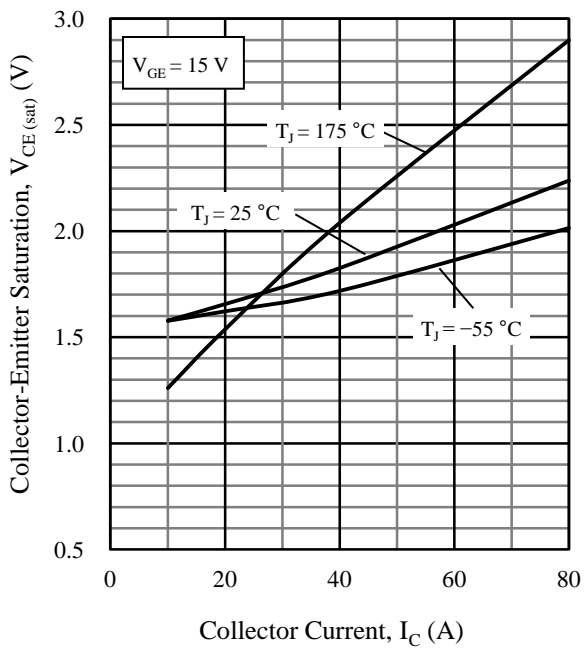


Figure 12. Saturation Voltage vs. Collector Current

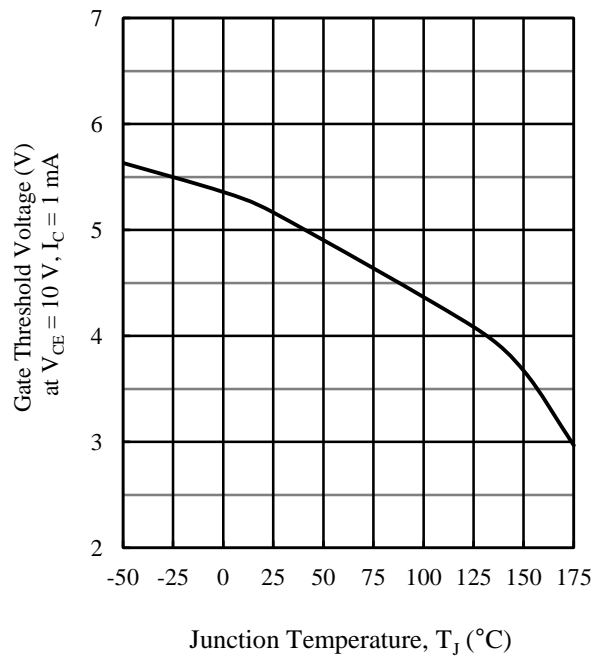


Figure 13. Gate Threshold Voltage vs. Junction Temperature

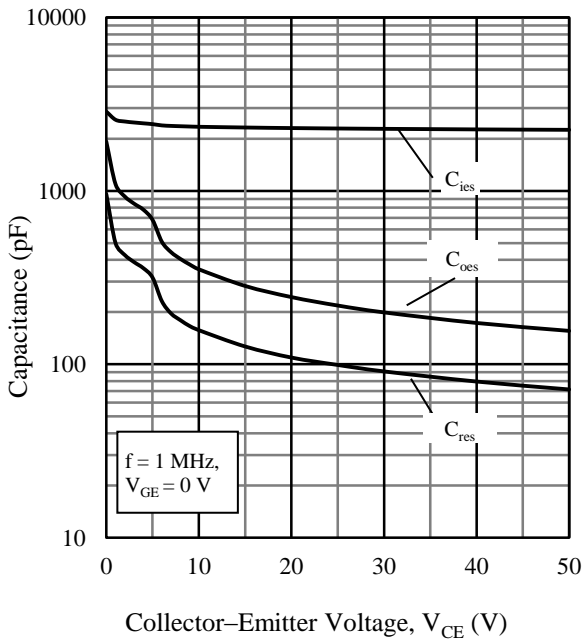


Figure 14. Capacitance Characteristics

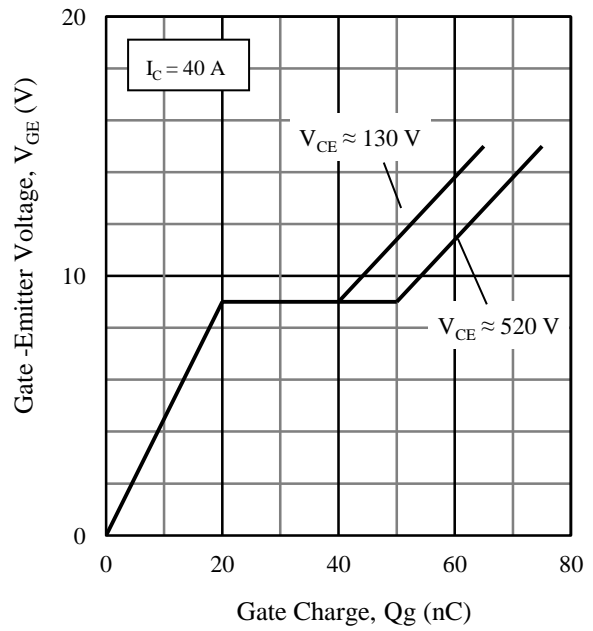


Figure 15. Typical Gate Charge

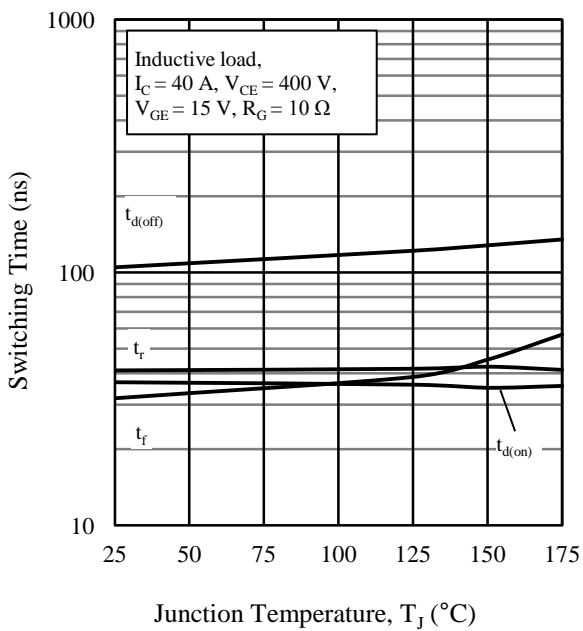


Figure 16. Switching Time vs. Junction Temperature

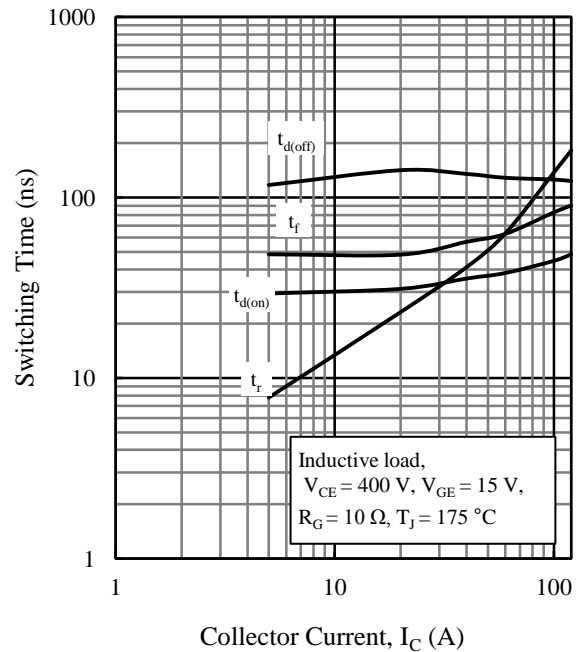


Figure 17. Switching Time vs. Collector Current



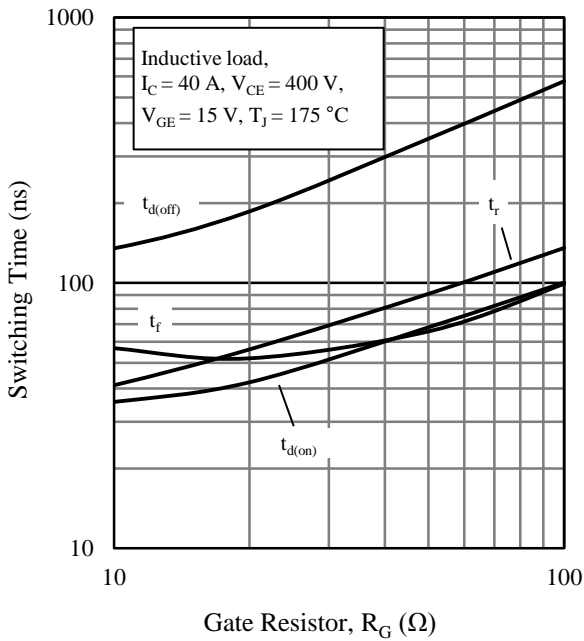


Figure 18. Switching Time vs. Gate Resistor

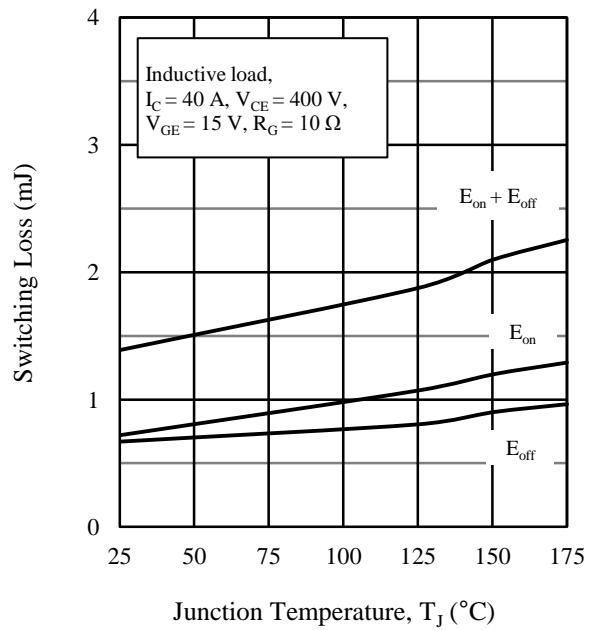


Figure 19. Switching Loss vs. Junction Temperature

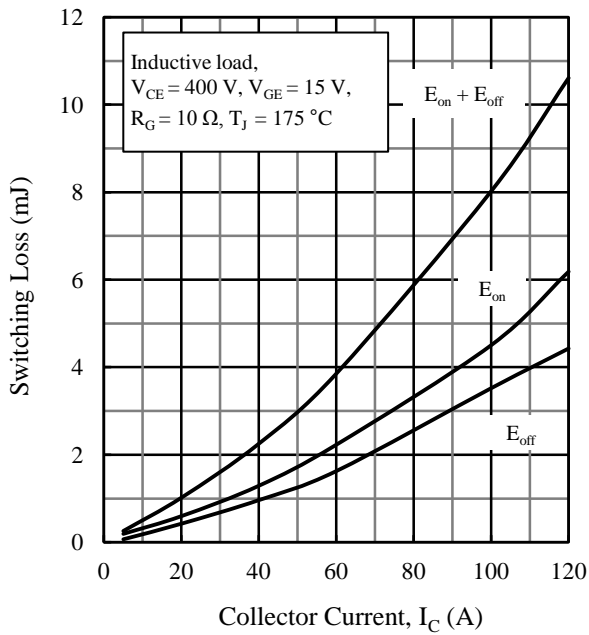


Figure 20. Switching Loss vs. Collector Current

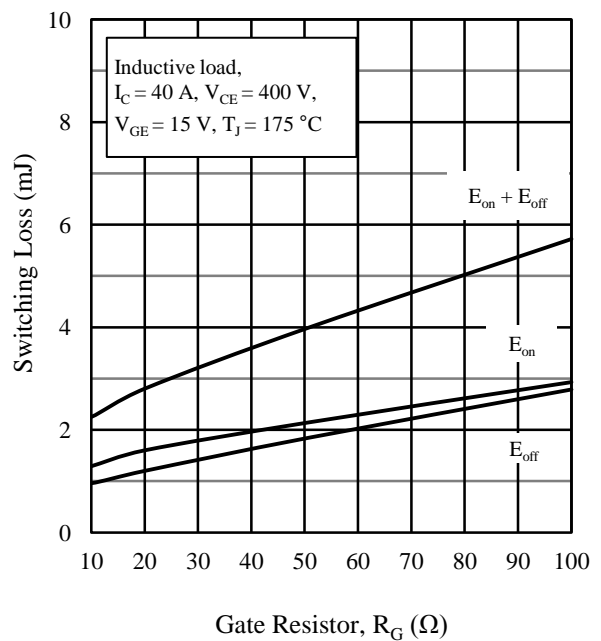


Figure 21. Switching Loss vs. Gate Resistor

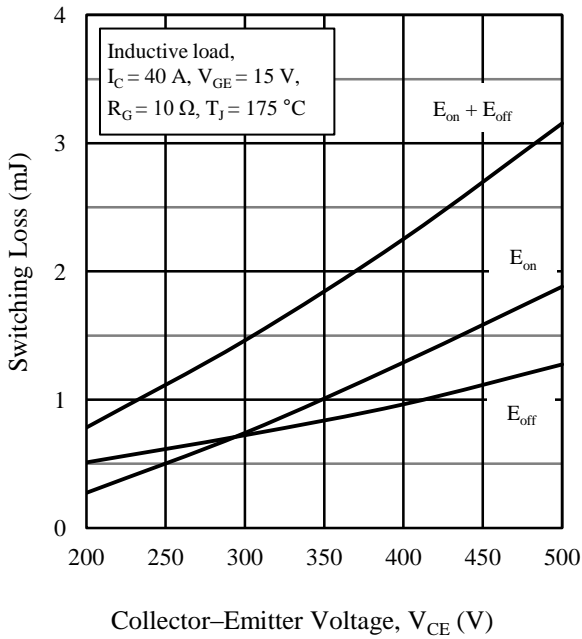


Figure 22. Switching Loss vs. Collector-Emitter Voltage

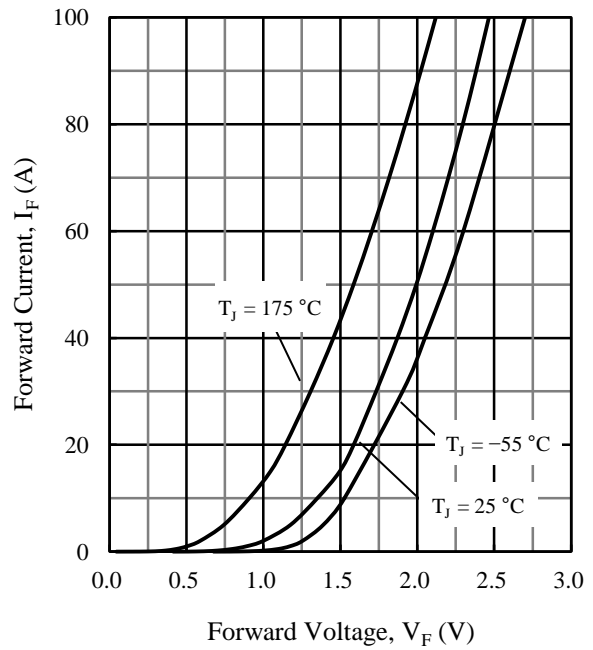


Figure 23. Diode Forward Characteristics

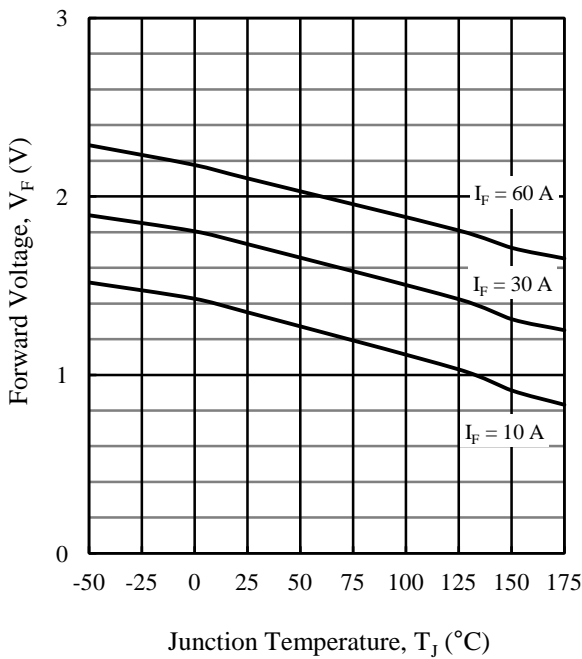


Figure 24. Diode Forward Voltage vs. Junction Temperature

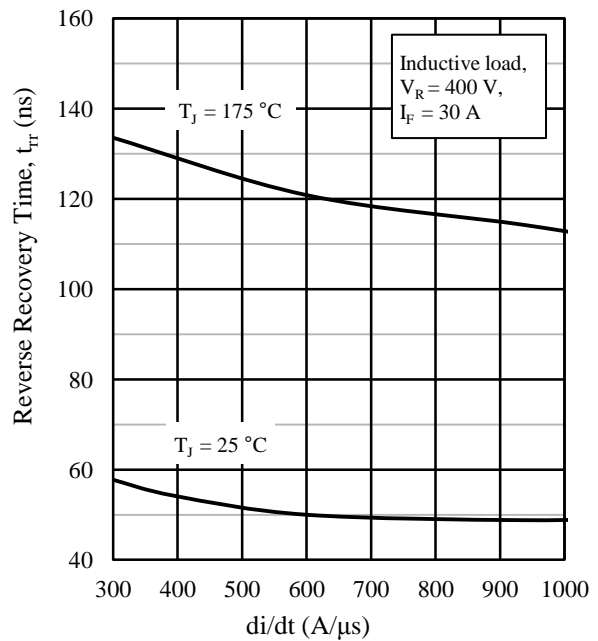


Figure 25. Diode Reverse Recovery Time vs.  $di/dt$

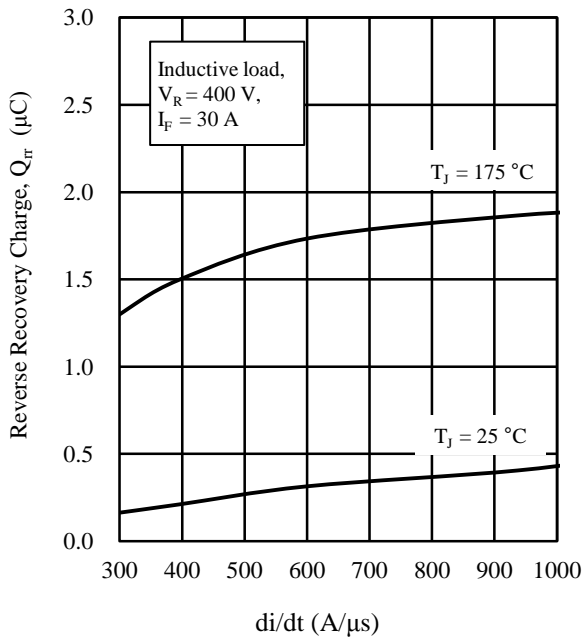


Figure 26. Diode Reverse Recovery Charge vs. di/dt

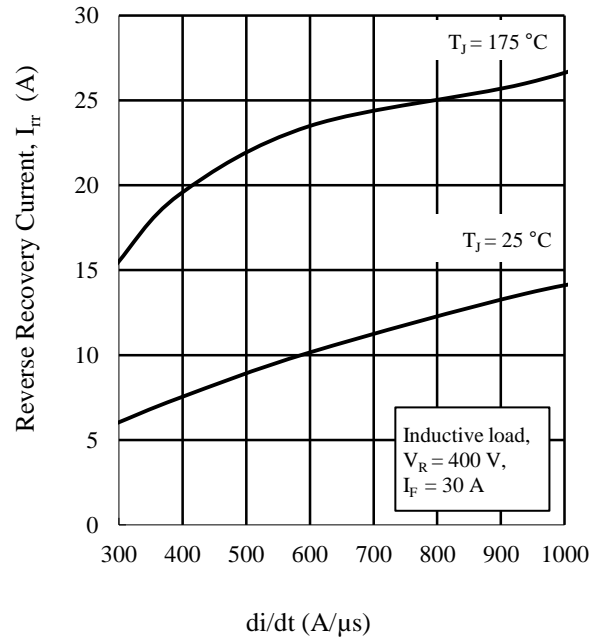


Figure 27. Diode Reverse Recovery Current vs. di/dt

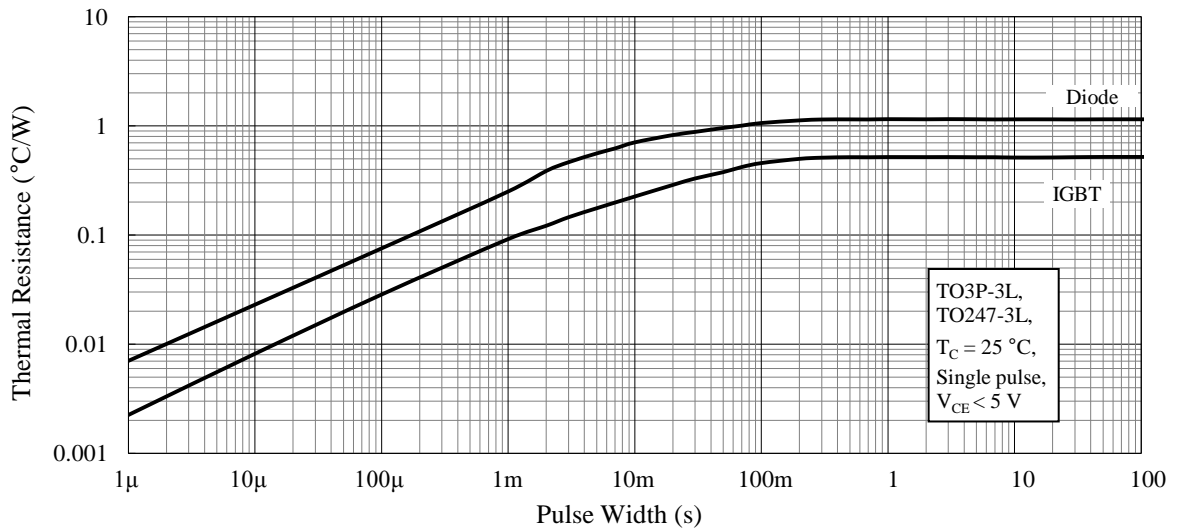


Figure 28. Transient Thermal Resistance (TO3P-3L and TO247-3L)

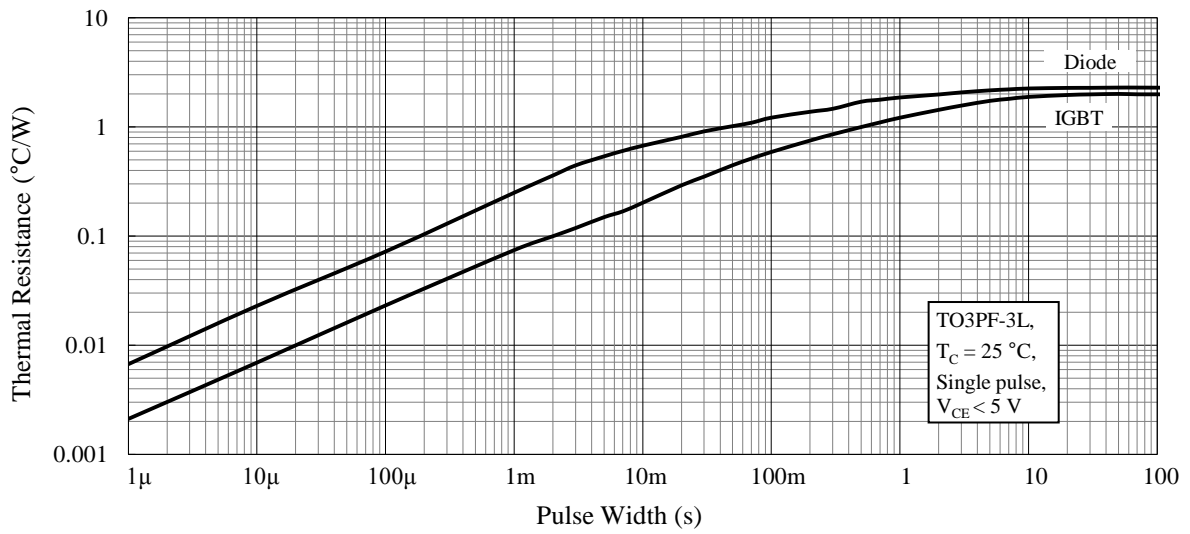
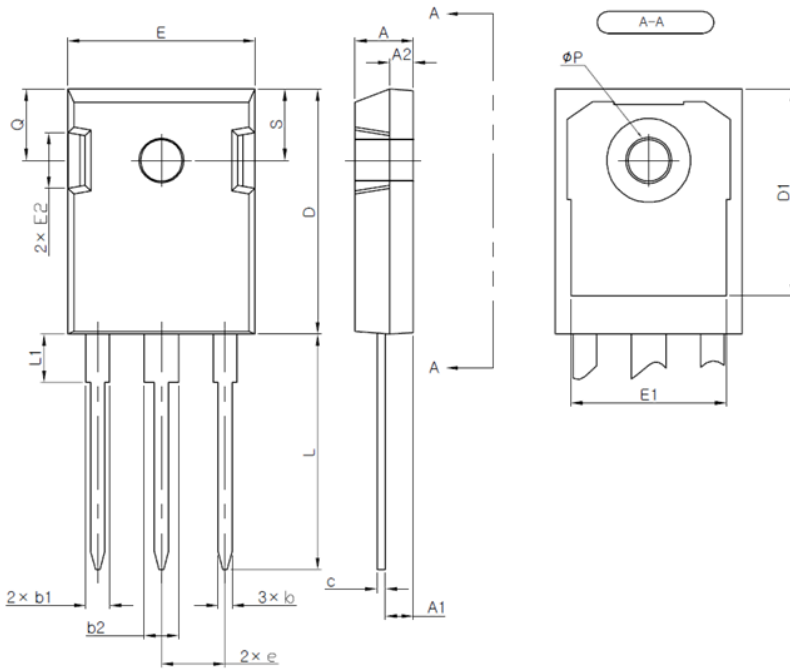


Figure 29. Transient Thermal Resistance (TO3PF-3L)

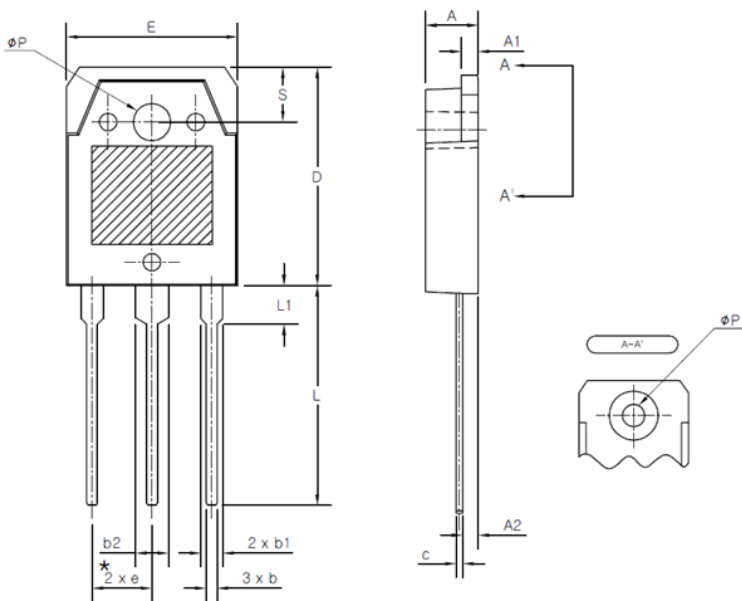

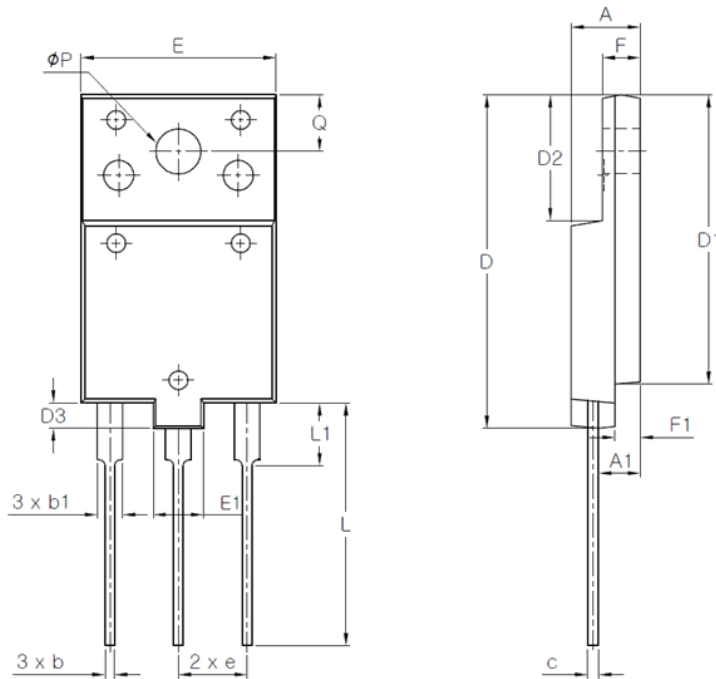

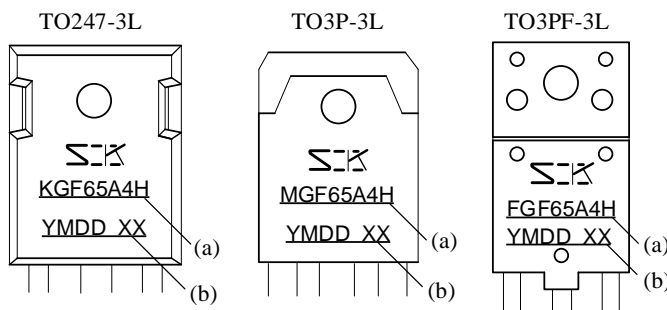
